The following addendum hereby amends and/or modifies the Bid Documents and Contract Specifications as issued for this project. All bidders are subject to the provisions of this Addendum. **Bidders shall acknowledge receipt of this addendum and utilize the latest bid schedule.**

Electronic bids will be received via Bid Express at www.bidexpress.com on behalf of the Cobb County Board of Commissioners, **until 12:00 noon August 13, 2026. NO BIDS WILL BE ACCEPTED AFTER THE 12:00 NOON DEADLINE.** No submitted bid may be withdrawn after the scheduled bid opening for a period of ninety (90) days.

All bids shall be accompanied by an Electronic Bid Bond via Bid Express a Paper Bid Bond, or a Certified Check delivered in a sealed envelope, indicating the project name and project number, to Cobb County Procurement Services Department, 1828 West Oak Parkway, Marietta, GA, 30062, **BEFORE THE 12:00 NOON DEADLINE.** Bid Bond shall be drawn in favor of the Board of Commissioners, Cobb County, Georgia, in the amount of five percent (5%) of the bid for the complete work.

Receipt of addenda must be acknowledged online at www.bidexpress.com. It is the bidder's ultimate responsibility to ensure that they have all applicable addenda prior to bid submittal and to utilize the latest bid schedule.

Proposals may be rejected if any of the Unit Prices are obviously unbalanced. The County will decide whether any Unit Prices are unbalanced either excessively above or below a reasonable cost analysis value determined by the Engineer, particularly if these unbalanced amounts are substantial and contrary to the interest on the County.

In an effort to meet Title VI requirements, contractors are encouraged to fill out the form in the bid package. This is strictly voluntary. Please place form in a separate envelope and deliver to Cobb County Purchasing Department.

I. QUESTIONS/ANSWERS

- Q. We will still require Temporary Barrier – Method 2 during Stage 1 when traffic on the existing bridge is reduced to one lane. Can the applicable pay item be revised to include the temporary barrier required on the existing bridge during this stage?
- A. **Per GDOT DPM 5.4.1, Temporary Barrier – Method 2 is only required where the distance from the centerline of the barrier to the free edge of the bridge deck is less than 6 ft. – 0 in. measured normal to the barrier. The distance from the centerline of the barrier to the edge of the bridge deck is 6 feet. Additionally, the existing guardrail along each side of the bridge is to remain in place during stage 1 construction. No Temporary Barrier – Method 2 will be required.**
- Q. There are currently no pay items for permanent pavement striping. Can the County please add the appropriate permanent striping pay items and provide a permanent striping plan for the project?
- A. **Striping is not required on Cobb County roads with speeds of 25 MPH or less. No permanent striping pay items will be added.**
- Q. An item for basic erosion control is included under the water scope. What is expected to be paid for here? We did notice two straw bale check dams shown on plans. Can the item be revised if this is all that is needed?
- A. **This pay item is used to pay for erosion control items, for water work, that extends beyond the limits of the roadway project.**
- Q. Is temporary bypass pumping required in order to keep the water main active during the replacement, or can the contractor cut and cap the water main on each side of the bridge?
- A. **The water main can be cut and capped on each side of the bridge.**
- Q. Are the water main hangers for the bridge to be paid for under the Bridge/Culvert crossing bid item?
- A. **Yes.**
- Q. Is the fire hydrant tee included with the hydrant item or is it to be paid under the fitting item?
- A. **Fire hydrant tee is paid for under fitting item.**
